SCHEDULING

If you're interested in scheduling a 15 min introduction Zoom meeting or Slack video call, the best way to reach out is through g-mail. I am currently accepting 20 hours per week of freelance work, but can remain flexible if the project extends over longer periods.

CONFIDENTIALITY

All client sessions, feedback/critique, and sensitive company information remain confidential and protected. I will send a permission form asking for consent to display any client work on my website or social with every welcome package and off-boarding processes. The client may refuse signature if the project is not suitable for public viewing.

RUSH JOBS

Any changes in timelines after the agreed upon contract is signed are subjected to rush fees which depend on the size of the project, the amount of deliverables (print and digital), and the current schedule of the designer (starts around \$25). The Graphic Designer may refuse service and break the contact without legal penalties if they cannot complete the work per the client's request. A professional referral may be offered in compensation and all client-owned materials will be returned through email.

Payment & Cancellations

PAYMENT PLAN

All payment plans are required a 50% deposit of the project's total estimated price. This deposit is NON-REFUNDABLE. I will subtract the deposit from the final total after invoicing is completed and email to the client with deliverables.

- 1. Clients may pay their flat rate 100% up front (pay any extra fees later)
- 2.Clients may do an installment plan with written agreement from the designer (drafted contract)

BILLING & PAYMENT METHOD

After we approve all deliverables, I will send out a digital invoice to the client through email. The client has 5-7 business days from the moment of receiving the document to complete the payment (or installment for that month). If a client goes no contact and ignores the contracted deadline for payment, legal action will take place to ensure all parties remain accountable for their part in the settlement. If a client cannot reach the payment deadline because of unforeseen circumstances, reach out to the designer, and we may readjust once deadlines with proper documentation. Repeated attempts for readjustments or forbearance will call for legal action as well. Balances must be paid in full before recieving all deliverables. Methods include PayPal, Venmo, & Direct Deposit.

CANCELLATION POLICY

The client or designer may cancel the requested project without extra fees or legal penalties at any point in the process (late or early). Any work the **designer has completed remains the intellectual property of the designer and it does not entitle the client to receive it unless stated in a previous written agreement**. They may buy the rights to the project at a negotiated flat rate from the designer if the client desires the unfinished work to bring forth to another vendor. These clients will receive written documentation of transformation of rights of the property in a legal document along with a receipt.




